**BASIC PROFESSIONAL SERVICES OF FUNERAL DIRECTOR, STAFF AND OVERHEAD      \$565.00**

This fee is for the basic services of funeral director and staff and will be added to the total cost of the funeral arrangements you select and is non-declinable. This fee is already included in our charges for DIRECT CREMATION, IMMEDIATE BURIAL, and FORWARDING OR RECEIVING REMAINS.

### This fee includes:

- Personnel available 24 hours a day, 365 days a year to respond to initial call.
- The arrangement conference.
- Coordinating funeral ceremony/service plains with clergy, cemetery, and/or other individuals involved in the final disposition of the deceased.

- Obtaining all legal documents, certificates and permits.

**EMBALMING AND PREPARATION ROOM      \$595.00**

Embalming is a chemical process which provides temporary preservation of the body and eliminates certain health hazards. A person licensed by the state of California must complete this procedure. Except in certain cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have a right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial.
